

31ST ANNUAL FSEA GOLD LEAF AWARDS

Judged on design, execution and level of difficulty, the annual Gold Leaf Awards Competition consistently draws entries from around the world and is committed to gaining visibility throughout the graphic arts community at large. From foil stamping and embossing to specialty coating, film laminating, laser cutting, diecutting, cold foil application, binding and more, the competition celebrates the quality, added value, shelf presence, security and brand recognition that these finishing processes lend to the printed sheet.

JUDGING

All judges are knowledgeable in print finishing processes. To ensure fairness, submitting companies are masked during the judging process and no judge may cast a vote for any entry submitted by his/her own company. Judges will select a Gold, Silver and Bronze award in each category. Additionally, a "Best of Show" award will be selected from among the Gold award winners in each category. The decision of the judges will be final. There will be no appeal of the judges' decision and no correspondence regarding the details of the judging.

Award winners in each category receive the following:

- In-person recognition at the FSEA Gold Leaf Awards Reception during the FSEA Print Embellishment Conference (April 9-11, 2024, Dallas, TX)
- A personalized award certificate suitable for display

- Additional recognition in other industry publications and industry events, including Folding Carton Industry, BXP Magazine, and the Showcase of Packaging Innovations at PACK EXPO 2024

- Each entry must be submitted with a separate entry form.
- Two finished pieces for each entry should be submitted per category. Please contact the FSEA if only one entry is available.
- Entires must not be mounted, and press sheets will not be accepted only finished pieces.
- There is no limit to the number of entries a company can submit. There is a one-time fee for the first entry. Each additional entry, no matter what the category, will be charged a subsequent fee. See entry fees for additional information.
- FSEA retains the right to re-categorize entries as necessary. This assures the fairest judging and affords the entrant the best opportunity for a gold, silver or bronze award.
- Entries cannot be returned and become the property of FSEA.
- Any company engaged in the production or design of decorative print materials may enter. It is not necessary to be an FSEA member. However, entry fees for non-members are higher.
- FSEA reserves the right to share images of entries.
